Your options:

In organizing an essay it is often helpful an	d necessary to use transitional words and phrases to show the	

In organizing an essay, it is often helpful and necessary to use transitional words and phrases to show the reader what's happening and to give them an idea of a timeline. Transitional words include "next," "first," and "however," and transitional phrases include things like "for example," "as a result," and "in conclusion." Using dates and times ("The next day," "an hour later,") can also signal a transition to a new point. Transitions can also show comparisons ("Like," "unlike," "Similarly," etc.). I have underlined twice any transitional words or phrases that you've used. Transitional phrases are often most necessary between paragraphs. If there are no obvious transitions between the paragraphs, I've made suggestions for how to move smoothly from one point to another.

I have answered the following questions on a separate sheet of paper in complete sentences OR I have written you a letter that includes my response to the following questions. I have used specific examples from your paper to answer these questions and I have numbered the paragraphs (if necessary) to make my points clear.

- 1. Does the introduction introduce the reason that the author wants to compare these two subjects? Do you understand what decision she or he is making? If not, what information should be added?
- 2. Did the author use point-by-point or subject by subject? Do you think this was a good choice? Why/why not?
- 3. Are there enough examples and details to make the comparison interesting, or is the paper dry in parts? Did you learn something from the comparison? If not, what would you like to see the author further explore? If so, what did you learn? Cite specific paragraphs as good examples or as places where more work is needed.
- 4. Do topic sentences and transitional words make the order and the comparison clear? Do you ever feel that one subject is getting more attention than the other? Where? Why?
- 5. Does the conclusion remind you, the reader, why the comparison was made in the first place?
- 6. What questions would you like to see the author answer in this essay?
